Discussion: Philosophy of National Championship Meets. While our National Championships need to be held in facilities of high quality, this is not the only consideration for awarding bids. Housing, Transportation, sponsors ability to proferly staff the meet, impact on the area and on Masters Swimming.

Purposes of the Championship Committee: As set forth in Art. III (F)(6) Appendix A, US Masters Swimming, but specifically:

.. Secure, review and recommend awarding of National Championships

.. Set standards and guidelines for National Championships by publishing a policy and procedure manual

.. Set up a jury system for handling protests

.. Work with Meet Directors in an advisory capacity to insure a consistent, quality approach.

Should Central Zone receive any priority in the awarding of 1983 Long Course Championships? Voted in favor of first consideration (3-1).

Letter from Gordon Smith relative to scheduling of National Championships on holiday weekends: Voted to leave to discretion of the Neet Director, (subject to USMS rules).

Protest from Ron Bull relative to scoring of 82 Long Course Nationals: Voted in support of Ron Bull's protest.

Protest from Chrus Georges relative to 1500 m. freestyle at 82 Long Course Nationals: No action on protest. Recommend rule change that when only one course is in use, the meet

director be required to offer willing competitors the right to swim two to a lane prior to any heats swimming one to a lane. In addition, to establish a voluntary time standard.

Rule Changes: USMS-7 - Team Scoring, voted in favor (3-1)

USMS-8 - entry deadline; voted against (4-0)

recommended entry procedure whereby deadline established requiring receipt instead of postmark,

change 35 days to 30 days.

USMS 9, 10, and 11; agree with intent, but should be <u>policy</u>. Proposed rule requiring that a swimmer who does not show at the block be scratched voted in favor (4-0). Given to Rules Committee for proper wording and presentation.

USMS-6 Referred to Championship Committee for development into policies and procedures. Recommended this be defeated at this time. (Withdrawn).

Also, I question using a postmark date for the closing. USS has not used a postmark date for many years as they had so many problems when they did.

SUGGESTED RULE AMENDMENT: I would like to suggest that we delete Section V-(H) National Championship Meets and substitute the following: (page 147 to page 150 of 1982 CODE)

- (H) NATIONAL CHAMPIONSHIP MEETS (Recommended for Regional Championships when possible)
 - (1) USMS National Championships shall be awarded in the following categories:
 - (a) Men's and Women's Short Course Swimming Championships to be held between April 1 and May 31.
 - (b) Men's and Women's Long Course Swimming Championships to be held between July 15 and September 15.

NOTE: Check dates of USS National Championship meets for conflict.

(2) The following rotation system shall be used when awarding the National Championships:

- (3) Conduct of National Championships National championships will be conducted under Section E - Swimming Rules, except as hereinafter specified. A general meeting of the Board of Governors, coaches and officials shall be held the evening prior to the first day's competition. The meeting date, time and location shall be included in the official meet information. All business pertinent to the operation of the championships and the conduct of the events shall be considered and finalized at this meeting, and no changes shall be made thereafter. Changes may be effected in the conduct of the meet to fit the situation and since changes can be made it is the obligation of every swimmer or his representative to be present at the meeting to be apprised of such changes, should they occur.
 - (a) Meet Director The meet director shall carry out the wishes of the Board of Governors in regard to the conduct of the meet.
 - (b) Computerization If possible, the organization(s) conducting the championship shall compile team lists, heat sheets and final results by computer.
 - (c) Heat Sheets Heat sheets listing heat and lane assignments for pre-seeded events and entry list by time (fastest to slowest) for deck seeded events, shall be made available to all swimmers on the morning of the day preceding the meet.
 - (d) Eligibility Protests There shall be a jury of three persons, appointed by the registration committee chairman or his designee, in attendance at every national championship to determine protests affecting the eligibility of any swimmer to compete or to represent an organization.
 - All protests made prior to or during the championship shall be submitted in writing.
 - ii. Protests shall be heard by the eligibility jury and decisions rendered, if possible, before the start of events on the day in which the protested swimmer competes, but no later than the last night of the championships. Opportunity shall be given for both the party lodging the protest and the party or parties charged to be heard.
 - iii. Unless the eligibility jury determines otherwise, the swimmer may compete under protest. The results of any race conducted under protest shall not be announced, nor prizes awarded, nor points scored until the eligibility jury has decided the protest, or the protest is withdrawn, unless the protest would not affect the final scoring or awards.
 - iv. The decision of the eligibility jury shall be used for the purpose of results, awards and scoring the meet.
 - (e) Technical Protests Written protests involving technical rules, except judgement decisions, must be filed within 30 minutes of the protested act or occurrence. Prior to the start of the meet, the president or his designee shall appoint a technical jury composed of two competitors in the meet and at least one, but not more than three, other persons.
 - (f) Scratch Procedure Any swimmer who fails to report to the proper lane in the correct heat of his/her entered event will not be permitted to swim that event at another time and will be considered scratched from that event. There is no penalty for scratching an event.
 - (g) Seeding
 - i. All events 200 yards/meters or less shall be pre-seeded, with the fastest heats swum first within each age group. If in any age group, there are not enough swimmers for a complete heat, all swimmers in that age group shall be seeded in adjacent lanes.

- ii. The 500 yd / 400 mtr freestyle and 400 yd/mtr individual medley may be either pre-seeded (as above) or deck seeded on time only, with the fastest times in the first heat, the second fastest times in the second heat, etc.
- iii. The 1650 yd / 1500 mtr freestyle shall be deck-seeded on time only, with the fastest times in the first heat, the second fastest times in the second heat, etc. When only one pool is used for both men's and women's events, the heats shall be apportioned and alternated by sex. At the meet director's option, willing competitors may swim two (2) in a lane when only 7, 8, 9 or 10 lanes are available for the event. All heats with two (2) competitors in a lane shall be completed before the heats with a single competitor per lane. This information must be stated on the entry blank. When two (2) competitors swim in a lane there shall be two automatic timing systems available. Seed two (2) competitors in a lane as follows:
 - 1) List all swimmers fastest to slowest and number.
 - 2) List all odd numbered swimmers fastest to slowest. This becomes group A.
 - 3) List all even numbered swimmers fastest to slowest. This becomes Group B. (We have taken one list and made two.)
 - 4) The fastest 7, 8, 9 or 10 A's become Heat 1A, and the fastest 7, 8, 9 or 10 B's become Heat 1B, etc. NOTE: This insures that swimmers of relatively equal ability will swim in the same lane.
 - 5) If starting at the same end of pool, A's swim in right half of lane and B's swim in left half of lane.
 - 6) If starting at opposite ends of pool, A's swim in half of lane to their right when starting and B's swim in half of lane to their right when starting.
- (h) When the depth of the swimming course varies, the male and female contestants shall share equal time in the deep end of the pool.
- (i) Scoring Scoring will be published for Men, Women and Combined totals. Mixed-Relay scores will be used for Combined totals ONLY.

- (j) Awards Medal awards will be awarded one through six and appropriate awards will be awarded 7 and beyond. The number of event awards given will be equal to the number of lanes used in the pool. A USMS Championship patch shall be awarded to the winner of each event. Awards will be given regardless of the nationality of the swimmer. Swimmers winning more than one Championship may purchase additional patches for each additional championship won. NOTE: Duplicate awards will NOT be given, except in the case of ties, as provided in 103.9 of the USS Technical Rules.
- (K) Final Results Meet results and team scores shall be published by the meet sponsor within 30 days and distributed to members of the Board of Directors and representatives of participating teams.
- (4) Events and Programs The following four-day program for championship meets shall be conducted with Women's events preceding Men's events:

(5) Entry Blanks and Information Booklet

- (a) The entry blanks shall be prepared under the joint direction of the president or his designee, the rules chairman and the meet director.
- (b) Such entry blanks shall conform exactly to the standard format agreed upon by the Board of Governors, and no other shall be used.
- (c) One set of the entry blanks shall be sent by first class mail at least 30 days prior to the closing date to all members of the Board of Governors.
- (d) The information booklet shall contain the meet director's name, address, phone numbers and all other pertinent information.
- (e) Entry fees for national championship meets shall be \$3.00 for individual events and \$8.00 for relays. A \$10.00 per person (swimmer) surtax may be charged (for national championship meets only) to be used by the meet sponsor to help pay meet expenses. A banquet or appropriate social event may be conducted for an additional fee. Participation in this event is optional.
- (f) The closing date for entries in all national championship events shall be no more than four weeks prior to the first day of competition.
- (g) The information booklet mailing, including preparation, printing and distribution, shall be the responsibility of the meet sponsor. Approval of data to be mailed shall be obtained by the president or his designee prior to printing and/or distribution.
- (h) The date, time and location of the general meeting shall be included in the official meet information.
- (i) It shall be the responsibility of the sponsor to ship the submitted entry blanks to the USMS <u>Secretary</u> immediately following the championships. Those entry blanks will be retained for a period of one year.

(6) Entries

- (a) Entry blanks, properly filled out and received prior to the meet entry deadline, will declare the swimmer officially entered.
- (b) Competitors may enter and swim in a maximum of 6 individual events in a four-day National meet with a maximum of 3 individual events per day. Competitors shall be allowed to swim in only one freestyle relay, one medley relay, one mixed freestyle relay, and one mixed medley relay per meet. Each team shall be limited to no more than three relays in each event in each age group. All Competitors, including members of relay teams, must fill out and sign the appropriate entry blank.
- (c) Entry times must be submitted for all individual events and relay events.
- (d) One member of each relay team shall pick up relay entry cards on which he shall list the competing relay swimmers, their first and last names, ages, order of swimming and sex (for mixed relays), for each entered relay. Upon reporting to the starting blocks, immediately prior to the start of the relay heat in which such team is entered, the completed relay entry card shall be handed to the head lane timer.
