Old Business

- By-law revisions:
 - Treasurer Chair by-laws outdated, as noted by our Chair in 2022, and they do not accurately reflect our actual practices. For example, our by-laws state the Treasurer can't write checks. This is not the norm for all other LMSCs researched. Steve and Jeremy are working together to update these by-laws so that they are in line with other LMSCs.
 - Need to change "Registar" to "Membership Coordinator" and update that Chair's job description
 - Dues & fees updated

New Business

- Delaware River Virtual Swim (partnered with ReSport)
 - NJ LMSC invites Metro and DV LMSCs to join event in 2025
 - How it works:
 - 330 mile virtual swim that runs from January 15 to May 15 with a rolling registration
 - Participants must be current registrants with your LMSC and can be solo or 3-4 person relays
 - Jeff Henderson, the head of ReSport, will charge each LMSC a \$50 setup and \$3/entry that each LMSC will pay
 - Each LMSC's participants will have their own color so the LMSCs will be differentiated from each other on the map.
- Proposed donation to PhilAquatics to support initiative to build world-class 50m pool in Philadelphia area

Highlights:

- DV LMSC was the Zones meet fee collector and expense payer (thus the unusually large meet fees & expenses this year)
- Cash on hand up from beginning of year until now (total ~30k)
- Main sources of income: membership fees, pool meet fees, other events
- Main expenses: pool meets
- No convention expenses (virtual)
- Portion of USMS membership fee allocated towards DV LMSC going from \$14 to \$12

 To make up for USMS deficit
- Sanctions fee going away
- Bring back incentive to have more teams reps attend X amount of \$ per swimmer if sent a rep to Annual Meeting
 - o \$100/club if send representative, starting 2025 Annual Meeting
- Target bank balance?
- DV LMSC now registered charitable organization in State of Maryland

Lifetime Swimming Performance Award

Winner – Tom Tulenko

Tom started swimming masters in the early 1980's at the Ambler Y with Melinda Wolff and Dick Schwem. He originally represented Valley Forge Masters which eventually became a workout group of Colonials 1776. Over the years he has achieved 28 individual USMS Top 10 times, mostly in distance freestyle events, as well as 8 relay top 10 times and has been a member of Del Val record setting relays. At certain points in his masters swimming career, Tom could be found swimming at the Ambler Y, Upper Main Line Y, Villanova, Germantown Academy, Friends Select, Greater Plymouth Community Center, and Nor Gwyn, possibly all in the same week! (This jokingly earned him the title of swim whore!) These days he no longer competes but can sometimes be found swimming (with fins) at Life Time Athletic in Fort Washington.

Top 10 Report

Highlights:

- 2024-2025 SCY event ranking in USMS database are messed up due to nationals being late. They are not fixing this but top-10 times will be correct for the season.
- SCY season ended on June 24 rather than on May 31 (as usual)
- For 2023 DV LMSC had the following top-10 results:
 - SCM = 87
 - LCM = 57
 - SCY = 105
- Relays still #1 uploading issue with meet results
- Want to encourage swimmers to use "One Event Fee" structure for recognized meets so that their race can be sanctioned and count for Top 10
 - \circ $\,$ Most often occurs with SCM meets
- Need to be diligent on bulkhead measurements before and after each session.

Coaches Report

Presented by Dave Schneider, Committee Chair

Highlights:

- DV Coach statistics
 - Was not able to determine how many Delaware Valley swimmers identified as coaches in 2024
 - 42 Delaware Valley coaches have achieved some level of USMS coaching certification, which is an increase of 33 certified coaches over 2023:
- The 2024 Nationals Coaching Clinic was held October 18-20 in Houston. Laurie Hug attended.
- Level 1 Coach Certification class now offered as online video
- No Level 2 or 3 coaching classes in our LMSC in long time, schedule for 2025 coaches classes not up yet
- People reach out to Jeremy about putting on coaching clinics in Philadelphia area (get LMSC involved)
- DV LMSC has policy to reimburse coaches attending training
 - Reimbursed 2 coaches in 2022-2023 season

USMS Convention Report

Our LMSC again earned three (3) delegate spots to the convention which was held in a "hybrid" format for the third time with both online and in-person attendees. All DV LMSC delegates attended virtually. House of Delegate meetings were held September 13th through September 15th.

Delegates were Jeremy Gross, Joe Boris and Laurie Hug. Laurie also represents the DV LMSC as a member of the USMS Coaches Committee but no longer gets an automatic delegate spot.

Highlights:

- All DV attended virtually. J. Gross, L. Hug, J. Boris were the DV LMSC Delegates
 - o Guy Davis elected as Colonies Zone At-Large director
 - o USMS Membership will be \$75 for 2025, 2026, and 2027
 - LMSC fee distribution reduced from \$14/member to \$12 in 2025 and \$10 in 2026 and 2027. Note this will be an ~\$1,900 reduction to DV in 2025 and \$3,800 reduction in 2026 and 2027

- o College Club Swimming Bridge Membership will now be \$0 (was \$25)
- Pool and Open Water sanction cost is now \$0 (was \$50 and \$100). Note we have always paid this, so we will net ~\$500 as a result.
- o A swimmer may now change clubs up to three times per year. There is no longer a 60 day waiting period after representing a club in a meet.
- o USMS considering eliminating hard copy of swimmer magazine or charging for hard copy
- Denise Escher attended volunteer relay convention this year (Oct. 18-20)
- Laurie Hug attended coaches convention this year (Oct. 18-20)
