USMS Finance Committee Sept. 13, 1996

The meeting reconvened at 10:15 AM with the following members present: Tom Brunson, Randy Nutt, Anna Lea Roof, Gene Donner, Doug Church, Kim Shaw, Richard Smith, Frank Newquist, Jeanne Ensign, Jeff Moxie, Katie Cooper. Roy Abramowitz and Lucy Johnson were present as ex officio members.

<u>BUDGET</u>

It was reported that we expect to have between 31,000 and 32,000 registered swimmers by year end. It was also reported that the registration committee proposes to change from Sept. 1 to August 1 for dues reduction, the effect of which will be to reduce income from dues by approximately \$5,000.

Treasurer Lucy Johnson asked if the committee wanted to take a position on the proposed change from Sept. 1 to August 1 for reduced dues. Following discussion, the committee MSC to recommend to the House of Delegates we keep the Sept. 1 date.

The committee discussed club fees. It was MSC to recommend to the House of Delegates an increase from \$10 to \$20 for, to take effect on 1-1-97.

The committee then undertook a comprehensive review of the proposed budget and made changes as deemed appropriate to the draft proposal.

Mel Goldstein asked the committee to address the issues of timely payment of bills and deposit of checks. It was agreed that:

- a) Receipts of contract payments and sponsorship funds need to be carefully tracked;
- b) Membership income needs to be immediately deposited;
- c) Bills of USMS need to be timely paid.

See FOG addition below for committee recommendations.

Jack Geoghegan made a brief presentation to the committee regarding reimbursements for non-officers members of the executive committee and the Controller.

The committee was also advised that the Planning Committee has obtained not-for-profit status for the USMS Foundation. The Chair, with consent of the committee, asked that a representative of the Finance Committee be involved in the planning of the Foundation.

The Committee MSC an overbudget expense for line item 5680 (ad hoc on-line computer committee) in the amount of any excess through year end. This was necessitated by the attempt to get our USMS WEB page on-line. The Committee MSC the Ad Hoc Committee to continue to explore ways to reduce and/or control costs of the WEB page.

The Committee MSC to accept the budget as amended and to recommend its adoption to the House.

FINANCIAL OPERATING GUIDELINES (FOG)

The committee then began an extensive review of the FOG. Action items follow.

- a) It was MSC to include the past president, legal counsel, zone chairman and the Controller for reimbursements under the same provisions applicable to the executive committee. FOG III.B.1.
- b) It was MSC following discussion that the bid minimum under FOG VII.A.1. be increased to \$1,500 from \$1,000.
 - c) It was MSC that a new section be added to FOG covering deposit policies. FOG I.F.
- d) MSC to include a policy for selection and reimbursement of a substitute committee chair during convention. FOG III.2.D.

After continued comprehensive discussion, it was MSC that FOG as amended be adopted.

The Finance Committee formally adjourned sine die at 11:30 pm with appropriate words of congratulation to one and all on the successful completion of the tasks at hand.
