USMS HOUSE OF DELEGATES MEETINGS

Burlingame, California September 1997

FRIDAY, SEPTEMBER 26, 1997

President Mel Goldstein called the meeting to order at 7:35 P.M. He announced that Hugh Moore had been elected as Zone Chairman.

Stephanie Walsh explained the election process for the Officer positions.
