UNITED STATES MASTERS SWIMMING LEGISLATION COMMITTEE FINAL REPORT

1. Subcommittee reports

- Sanctions/Approvals Bill Early presented a review of what work had been performed during the last year. A survey of all LMSCs about their sanctioning processes was compiled and presented.
- Labiba b. ad Goals & Objectives - Elin Zander presented a review of 3 proposed options to replace the current goals section in the rule book. The results were submitted as the new L-42.
- Rule Book Part 4 Jeanne Crouse presented a draft of a proposed C. Part 4 to cover any nebulas and ambiguous areas. It was tabled to be reviewed by the committee members until the next convention. The Legislation Committee would like to advise the House of Delegates that this section of the rule book is an important issue. and that the committee plans to continue to work on it during the year and to present it to the House of Delegates as emergency legislation next year.
- Liability Release Jack Geoghegan indicated that there was work , b mages, being performed on the Liability Release because of pending litigation about a problem encountered in California. liability release statement is included as L-41.

As a condition of my participation in the Masters Swimming program or any activities incident thereto, I hereby waive any and all rights for claims for loss and damages, including all claims or loss or damages caused by the negligence, active or passive, of the following: United States Masters Swimming, Inc., the Local Masters Swimming Committees, the clubs, host facilities, meet sponsors, meet committees, or any individuals officiating at the meets or supervising such activities, as a condition of my participation in Masters Swimming. In addition, I agree to abide by and be governed by the rules of USMS"

L-42 Goals and Objectives statement - Replace the whole section with the following wording:

USMS MISSION STATEMENT

To promote fitness and health in adults by offering and supporting Masters Swimming programs.

USMS GOALS AND OBJECTIVES

- A. To offer adults the opportunity to participate in a lifelong fitness and/or competitive swimming program.
 - B. To encourage organizations and communities to establish and sponsor Masters Swimming programs.
 - C. To encourage and promote improved physical fitness and health in adults.
 - D. To enhance fellowship and camaraderie among Masters Swimmers.

- :3.5 To transfer representation from one club/organization or unattached to another club a A swimmer shall must serve sixty (60) consecutive days without having not represented any club/organization in competition for sixty (60) consecutive days before transferring affiliation to another club, regardless of his residency, unless this transfer takes place at the time of annual registration/re-registration. A swimmer may declare his affiliation as unattached at any time without written application.
- -4.6 A club wishing to change its LMSC affiliation must approve such a change by a majority vote of its general membership at a regular club meeting or at a special meeting called for that purpose, with the vote duly certified by the club's president and secretary. The transfer also must be approved by a majority vote of the officers of the club's current and proposed LMSCs. If approved, the transfer shall be effective sixty days after receipt of written notice by the National Registrar.
- -5.4 An unattached competitor is a registered swimmer who represents no club.
- -6.7 All applications for changes of registration (including transfers) must be accompanied by a reasonable fee to be determined by the local registration committee in the LMSC in which the swimmer will be registered after the change of registration.
- .7.1 There shall be only one USMS registration per individual swimmer permitted at any one time. Rationale: Re-orders for logic, eliminates some redundancy ("club" is defined in the Glossary as an organization that is permanent in character), and states what has been policy.

Rationale: For USMS Records and Top Ten, swimmers should be required to swim against other Masters. The heat in which a time is achieved should be a Masters (USMS, YMCA, Senior Olympic, etc.) only event/heat. Meets with both USS and USMS separately sanctioned events would be permissible.
