She will send the proposed revisions to each Legislation Committee member for review during the next year. It was suggested that the Legislation Committee update this section on a regular basis (every other year) in order to keep the information current.

Sanction applications for meets that are International in scope or nature shall be made to the LMSC within whose territorial limits the event is held in accordance with 202.1.1.A and shall be reviewed and approved by the Executive Committee of the House of Delegates before a sanction can be granted.

202.2.G

Recognition for foreign meets, other than those organized by FINA, MSI or CASA, shall be obtained from the USMS Registration Committee Chairman Executive Committee.
