OBJECTIVE: To recommend an IBM compatible computer program for registering USMS swimmers starting with the 1988-1990 contract period that can be used by the National Registrar and LMSC's

REQUIREMENTS: Using input from the Position Announcement, Computer Committee Report (Leo Letendre) and members of this committee a summary level of program requirements was developed. Each program was measured against these requirements.

Looking for a program that would work for the National Registrar and the LMSC's Registrar.

Program should be easy to use, menu driven with well written, easy to understand documentation.

Need the ability to produce monthly update transactions via floppy disks.

Need the ability to read a disk written in a "standard format" from any IBM program for updating the National Registrar's Database.

THIS PROGRAM DOES NOT EXIST

What we found was a variety of methods including manual systems, word processors, spread sheets, database management systems, and specific programs written in Basic.

RECOMMENDATION: The program that comes the closest to what we need is the one used by Pacific (Nancy Ridout) written by Michael Boerstein.

Used by an LMSC that has over 6000 members.

Written in DBASE and compiled so it can be distributed without requiring an LMSC to own DBASE.

NEXT STEPS:

Committee needs to work with the programmer to establish the changes/additions we want in the program.

Perform an acceptance test.

Assist in writing a User's Manual.

Recommend a procedure for implementing this new program.

Transactions (adds, modifies, transfers) for the
National Program

Process a disk of Update Transactions from each LMSC that can generate the required record format

DISK BACKUP STORAGE

Produce Quarterly and End of Year Copy of All Files

ADDITIONAL FEATURES

Check for duplicate swimmers

Provide screen reports of selected segments of the files

Check on swimmer's registration by using the name, display on screen

Input both age and date of birth to check the age

Menu driven with as many data fields as possible filled in by the program like state, zip and LMSC#
