

MINUTES OF THE SOUTH CENTRAL ZONE MEETING
SEPTEMBER 23, 1989 PORTLAND, OR

THE MEETING WAS CALLED TO ORDER BY KRIS WINGENROTH AT 8:10 AM.

PRESENT WERE: CRAIG TRIBUZZI, BILL HALL, AND LYNN CASEY FROM SOUTHWESTERN; JEFF THIBODEAUX AND EMMETT HINES FROM GULF; MARCIA MARCANTONIO, LIBBY NEUFELD, AND ED DANEHY FROM SOUTH TEXAS; DON MEHL FROM BORDER; AND KATHY KEFFER-SHARPE AND DENNY RYTHYER FROM OKLAHOMA. WEST TEXAS AND ARKANSAS WERE NOT REPRESENTED.

LAST YEARS MINUTES WERE APPROVED.

LMSC REPORTS WERE GIVEN.

ARKANSAS - NO DELEGATE PRESENT

OKLAHOMA - THERE IS A NEW 50 METER POOL IN O.K.C. (KATHY KEFFER-SHARPE)

SOUTH TEXAS - ALL SAN ANTONIO TEAMS ARE CONSOLIDATING INTO ONE TEAM. THERE IS A NEW TEAM FORMING IN ROUND ROCK. SPORTS PSYCHE IS NOW AUSTEX AND HAS JOINED THE LMSC. THERE IS A NEW SLATE OF OFFICERS. (MARCIA MARCANTONIO)

SOUTHWESTERN - BY-LAWS HAVE BEEN CREATED AND A SWIM GUIDE IS BEING WRITTEN. THEY ARE WORKING ON INCREASING THE NUMBER OF COMPETITIONS AND ENCOURAGING FITNESS SWIMMERS TO PARTICIPATE. LONE STAR WAS ADDED TO THEIR LMSC WHICH ACCOUNTS FOR THE HUGE JUMP IN NUMBERS BUT REGISTRATION WOULD HAVE BEEN UP ANYWAY. MAY PUT ON A CABLE SWIM. (CRAIG TRIBUZZI)

GULF - LONE STAR IS NO LONGER IN THEIR LMSC BUT REGISTRATIONS ARE UP. THE WOODLANDS WILL BE HOSTING THE LONG COURSE NATIONALS. OPEN WATER SWIMS (PRACTICES) ARE BECOMING POPULAR. (JEFF THIBODEAUX)

BORDER - THE MASTERS HAVE GROWN ENOUGH TO BECOME SEPARATE FROM THE AGE GROUP TEAM FOR THE FIRST TIME. THEY TRAIN SHORT COURSE METERS IN THE SUMMER. SEVERAL SMALL MEETS ARE HELD EACH YEAR. THERE ARE FIVE INDOOR 25 YARD POOLS IN THE CITY OF EL PASO. (DON MEHL)

WEST TEXAS - NO DELEGATE PRESENT. A LETTER FROM DAVE DONNELL REPORTED THAT ABILENE NO LONGER HAS A TEAM BUT THAT REGISTRATIONS ARE UP SLIGHTLY.

TOP TEN REPORT. IDA HLAVACEK WAS NOT PRESENT TO GIVE REPORT. TOP TEN RECORDERS WERE REMINDED TO SEND IDA A COPY OF THEIR TOP TEN REPORTS AS SOON AS POSSIBLE. IT WAS DISCUSSED WHY PEOPLE WERE OFTEN LEFT OFF THE LIST AND POINTED OUT THAT IT WAS NORMALLY DUE TO THE TIME NOT BEING REPORTED PROPERLY TO IDA.

ZONE MEET REPORTS. SHORT COURSE - BILL WALKER SENT A REPORT INDICATING THEY HAD ABOUT 200 SWIMMERS MOSTLY FROM TEXAS WITH A FEW FROM OKLAHOMA AND ARKANSAS.

LONG COURSE. NO REPORT WAS RECEIVED FROM LARRY WOOD. THE MEET WAS DISCUSSED AND THE LACK OF OFFICIALS WAS MENTIONED AS A PROBLEM. IT WAS POINTED OUT THAT THE GULF IS HAVING TROUBLE GETTING THE COOPERATION FROM THEIR LOCAL OFFICIALS.

MEET SCHEDULE. THE MEET SCHEDULE WAS PRESENTED. ONLY ONE BID EACH FOR THE LONG COURSE AND SHORT COURSE MEETS WERE RECEIVED. IT WAS MOVED, SECONDED, AND CARRIED TO ACCEPT THE ZONE BIDS AND THE MEET SCHEDULE AS AMENDED. (SEE ATTACHED).

ED DANEHY ASKED WHETHER IT WOULD BE ACCEPTABLE TO ADVERTISE OUTSIDE THE ZONE FOR PARTICIPANTS IN THE ZONE MEET SINCE THEY FACE SUCH LARGE MEET COSTS. IT WAS MOVED, SECONDED, AND CARRIED THAT THE ZONE ENCOURAGE PARTICIPATION BOTH INSIDE AND OUTSIDE THE ZONE FOR THE MEET.

LONG DISTANCE REPORT. CRAIG TRIBUZZI HAS PRODUCED A GUIDE FOR LONG DISTANCE SWIMS. YOU MAY CONTACT HIM FOR A COPY. THIS YEARS CATFISH CRAWL WAS CANCELLED DUE TO HIGH WATER.

ZONE FINANCE COMMITTEE REPORT. ED DANEHY REPORTED NO PROGRESS. LYNN CASEY AND LIBBY NEUFELD WERE ADDED TO THE COMMITTEE AND ASKED TO MAKE A REPORT NEXT YEAR.

ELECTIONS. KRIS WINGENROTH WAS NOMINATED AND REELECTED AS ZONE CHAIRMAN.

ZONE MEET CRITERIA REPORT. NO COMMITTEE MEMBERS WERE PRESENT BUT A DRAFT OF THEIR WORK WAS PRESENTED. THE DOCUMENT WAS DISCUSSED AND REVISED. A MOTION WAS MADE, SECONDED, AND CARRIED TO ACCEPT THE DOCUMENT AS REVISED. THE DOCUMENT WILL BE SENT TO THE MEET DIRECTORS FOR THE 1990 ZONE CHAMPIONSHIPS AS AN ADVISORY DOCUMENT AND WILL BECOME MANDATORY IN 1991. ANOTHER ZONE MEET CRITERIA DOCUMENT THAT HAD BEEN PREPARED BY CRAIG TRIBUZZI WAS PRESENTED. DON MEHL WAS ADDED TO THE COMMITTEE TO BEGIN TO REVISE THE DOCUMENT CRAIG PRESENTED.

NEW BUSINESS. A LIST OF FACILITIES CAPABLE OF HOLDING A NATIONAL CHAMPIONSHIP WAS MADE. THIS INCLUDED THE FACILITIES AT THE UNIVERSITY OF TEXAS, THE UNIVERISTY OF ARKANSAS, THE WOODLANDS, AND THE NEW POOL IN OKLAHOMA CITY.

IT WAS MENTIONED THAT SOME ZONES HAVE A PATCH THAT THEY GIVE TO RACE WINNERS TO HELP PROMOTE THE ZONE CHAMPIONSHIPS.

HAM ANDERSON, THE USMS HISTORIAN, REQUESTED THE ZONE COMMITTEE TO SOLICIT PHOTOS, SMALL EDITORIALS, AND OTHER INFORMATION FOR INCLUSION IN HIS HISTORY OF MASTERS SWIMMING BOOK. HE ALSO REQUESTS THAT HE BE PUT ON THE MAIL LIST FOR NEWSLETTERS. HIS ADDRESS IS:

**SOUTH CENTRAL ZONE CHAMPIONSHIP
BIDDING PROCEDURE AND CRITERIA**

BIDDING PROCEDURE

1. APPLICATION FORMS FOR BIDDING FOR THE ZONE CHAMPIONSHIPS SHALL BE AVAILABLE FROM THE ZONE CHAIRMAN.
2. BIDS FOR THE ZONE MEETS SHALL BE PRESENTED AT THE ZONE MEETING AT THE USMS NATIONAL CONVENTION. BID APPLICATIONS SHOULD BE IN THE HANDS OF THE ZONE CHAIRMAN FOUR WEEKS PRIOR TO THE CONVENTION.
3. THE BID WILL BE SELECTED BY VOTING MEMBERS ATTENDING THE ZONE MEETING AT THE USMS CONVENTION, BY A SIMPLE MAJORITY.
4. THERE SHALL BE A ROTATION SYSTEM FOR HOLDING THE MEETS. SHOULD A SUITABLE BID NOT BE RECEIVED BY THE ZONE CHAIRMAN FOUR WEEKS PRIOR TO THE CONVENTION, THE MEET BID SHALL BE OPEN TO ANY LMSC. THE ROTATION SHALL BE AS FOLLOWS:

1990	SOUTH TEXAS	OKLAHOMA
1991	SOUTHWESTERN	ARKANSAS
1992	GULF	BORDER, WEST TEXAS

1995	BORDER, WEST TEXAS	GULF

MEET CRITERIA

1. THE MEET SHALL BE A TWO DAY MEET.
2. AUTOMATIC TIMING SHOULD BE PROVIDED. (IF AUTOMATIC TIMING IS NOT AVAILABLE, 3 STOP WATCHES PER LANE MUST BE PROVIDED.)
3. AWARDS SHALL BE PROVIDED AS FOLLOWS:
 - A. 1ST - 3RD FOR EACH AGE GROUP IN ALL INDIVIDUAL EVENTS.
 - B. HIGH POINT AWARD FOR EACH AGE GROUP.
4. PARTICIPATION AWARDS SHOULD BE AVAILABLE EITHER FREE OR FOR A COST BASED FEE TO PARTICIPANTS.

5. A SOCIAL SHOULD BE HELD.
6. A HEAT SHEET OR PSYCH SHEET SHALL BE AVAILABLE TO EACH PARTICIPANT.
7. DECK ENTRIES MAY BE ACCEPTED AT THE MEET DIRECTORS DISCRETION.
8. A MINIMUM OF 2 OFFICIALS AS DESCRIBED IN THE USMS RULE BOOK SHALL BE WORKING THE MEET. THESE JUDGES SHOULD BE USS OR YMCA CERTIFIED.
9. RESULTS SHALL BE TABULATED AND SENT TO EVERY SOUTH CENTRAL TOP 10 CHAIRMAN AND EVERY PARTICIPATING TEAM WITHIN (30) DAYS OF THE LAST DAY OF THE MEET. TABULATION OF MEET RESULTS MUST MEET THE GUIDELINES AS ISSUED BY THE USMS NATIONAL OFFICE.
10. PARTICIPANTS SHALL BE ABLE TO ORDER ADDITIONAL COPIES OF THE MEET RESULTS AT A NOMINAL FEE.
11. IN ADDITION TO THE NORMAL SANCTION FEE, A REFUNDABLE SANCTION DEPOSIT FOR AN AMOUNT ACCEPTABLE BY THE SANCTIONING LMSC UP TO FIFTY DOLLARS (\$50.) SHALL BE CHARGED AT THE TIME THE SANCTION IS ISSUED. THIS AMOUNT WILL BE RETURNED IF ALL MEET CRITERIA ARE MET. PARTIAL DEPOSIT REFUNDS MAY BE MADE IF MOST BUT NOT ALL THE CRITERIA ARE MET. SHOULD A DISPUTE ARISE OVER THE RETURN OF THIS DEPOSIT, THE ZONE CHAIRMAN SHALL APPOINT A 3 MEMBER ARBITRATION COMMITTEE TO REVIEW THE CASE. THE COMMITTEE'S DECISION SHALL BE BINDING.
12. A MEET DIRECTOR ACCEPTING A BID SHALL RECEIVE A COPY OF THESE REQUIREMENTS AND SHALL SIGN AN ACKNOWLEDGEMENT ACCEPTING THESE CONDITIONS.

MEET ENTRY FORM

1. THE MEET ENTRY SHALL BE MAILED A MINIMUM OF 8 WEEKS IN ADVANCE OF THE MEET TO DESIGNATED PERSONS. THE ZONE CHAIRMAN OR EACH LMSC REGISTRAR SHALL PROVIDE THE MEET DIRECTOR WITH A LIST OF REGISTERED CLUB REPRESENTATIVES. AN ENTRY SHALL BE MAILED TO EACH CLUB REPRESENTATIVE.
2. A LIST OF PLACES TO STAY SHALL BE INCLUDED IN THE MEET INFORMATION.
3. COMPLETE DIRECTIONS TO THE POOL SHALL BE INCLUDED IN THE MEET INFORMATION.
4. THE MEET SHALL BE OPEN TO ANY USMS REGISTERED SWIMMER REGARDLESS OF LMSC REGISTRATION.

5. THE MEET ENTRY MUST MEET ESTABLISHED USMS SANCTION GUIDELINES.
6. A SANCTION MUST BE RECEIVED FROM THE LMSC IN WHICH THE FACILITY IS LOCATED.

RECORDS

1. ZONE MEET RECORDS WILL BE MAINTAINED AND LISTS OF THESE RECORDS SHALL BE AVAILABLE AT THE MEET.
